



#### **GLOSSARY**

Effective Duration is a measure of interest rate sensitivity, considering dollar price, coupon rate, maturity, call structure, and more. Effective Maturity is a measure of maturity which considers the possibility of bonds being called prior to maturity and refers to the most likely date that the final principal value will be received. Credit Quality is calculated using the highest rating assigned by nationally recognized statistical rating organizations (NRSRO) Moody's, S&P, or Fitch. The Not Rated category consists of securities that have not been rated by an NRSRO. If ratings agencies assign different ratings to the same security, the Adviser will use the highest rating as the credit rating for that security. Ratings are expressed as letters ranging from 'AAA', which is the highest grade, to 'D', which is the lowest grade. Cash and cash equivalents (such as money market funds) as well as municipal bonds pre-refunded with AAA-rated collateral are categorized as AAA. Corporate sector exposure is represented by Bloomberg BICS sectors. Municipal sector exposure is represented by Bloomberg BCLASS classification schema.
