PERFORMANCE (AS OF 3/31/2025)







GLOSSARY

Effective Duration measures the sensitivity of bond (and bond mutual fund) prices to interest rate movements, which considers a bond's dollar price, coupon rate, maturity, call structure, and more. Effective Maturity is a measure of maturity which considers the possibility of bonds being called prior to maturity and refers to the most likely date that the final principal value will be received. Credit Quality is calculated using the highest rating assigned by nationally recognized statistical rating organizations (NRSRO) Moody's, S&P, or Fitch. The Not Rated category consists of securities that have not been rated by an NRSRO. If ratings agencies assign different ratings to the same security, the Adviser will use the highest rating as the credit rating for that security. Ratings are expressed as letters ranging from 'AAA', which is the highest grade, to 'D', which is the lowest grade. Securities rated 'BBB-' or greater are classified as investment grade. Cash and cash equivalents (such as money market funds) as well as municipal bonds pre-refunded with AAA-rated collateral are categorized as AAA. Corporate sector exposure is represented by Global Industry Classification Standard (GICS) sector classifications. Municipal sector exposure is represented by Bloomberg BCLASS sector classifications.
